David Nielsen – responded and advised yes the fence is expected to be erected early in the new year. Funds to come from the Reserve Fund – estimated cost of \$162,500 which includes contingencies.

#### 7.4.1 Proposed Amendment to the Carnarvon Waste Site Fees & Charges

David Nielsen - it was \$40 but trying to incentivise to separate and therefore proposing \$35/t for commercial customers.

CEO – maybe there needs to be more clarity in the motion – will discuss in session at the Council Meeting.

## 7.4.2 Approval to Accept and Utilise Additional 2024/2025 Regional Road Group Funding on the Quobba/Gnaraloo Road

#### 7.4.3 Floating Pontoon Jetty Repair Options

General discussion on technical specifications of the pontoon jetties. President – the struts only last 10 years with no maintenance. If they were regularly maintained would they last longer.

David Nielsen – unfortunately the strut system comes in a sealed unit so unable to carry out any maintenance or repair parts.

## 7.4.4 RFT 09/20224 Plant and Operators for Flood Damage Repairs – AGRN 1118 Award of Tender

#### Cr Skender declared an Impartiality Interest

David Nielsen – was surprised that Council only received 3 submissions. The tenders did not provide a compelling case with 2 submissions significantly at a higher cost than budgeted for with one submission considered to be too low in cost.

Cr Dudley Maslen – one submission was too low - what is considered as too low ? David Nielsen – we know about how much everything costs from past experience and with a low cost also opens up the request for variances in the contract.
