2.4 INFRASTRUCTURE SERVICES

7.4.1 RFT 10/24 – Civic Centre Upgrades

Cr B Maslen – can we renegotiate. CEO – we can but have to follow proper process and a Council decision needs to be made on the matter before we can progress to this stage. Shire President – did the tenderers have working drawings Stefan Louw – yes Shire President – why is there such a big increase in the costings – what is the reasoning, do we know?

Stefan Louw – cyclone ratings due to evacuation centre has an impact on the materials and cost required plus the tenderers have also allowed for a number of contingencies.

Shire President – so the standards for an evacuation centre are very high?

Michael Mallong – yes – internal works are achievable however the external works to the building are the most costly.

7.4.2 Request for Consideration of Warroora East and North Roads as Roads of Regional Significance

Cr B Maslen – will this be discussed at the RRG meeting this week.

David Nielsen – yes and the letter of request from M Horack will be included for discussion

Cr Cottrell – the Warroora North Road cannot be used for emergency services due to its condition. Coral Bay covers emergencies at Warroora should they occur.

Cr B Maslen – if Council agrees, would we consider removing Banksia Drive from the listing as it is not happening.

Cr Cottrell – the road has no opening date at this moment but not sure that it is not happening.

Shire President – the closure has been extended due to the RAC development
