5.0 GENERAL BUSINESS AS PERMITTED BY THE SHIRE PRESIDENT

Mr Keith Deimel asked that he be permitted to speak with the Shire President agreeing to his request and asking questions.

Question 1 - In the audit it shows that Council's income is \$17m however it also states that Council's expenditure is 21m - In where is the shortfall coming from?

Answer- CEO Mrs Andrea Selvey advised that a full explanation will be provided in a letter.

Statement 1 - Council has a 60% staff turnover which is of serious concern and cannot be productive for Council. You have 70 people employed with most of the work relative to the town being conducted by Council. The Council are currently conducting all the work where in fact the Council should be managing.

Question 2 – With the Horizon Power works currently happening next to our property this is causing us great disturbance with noise and activity. They have also cut down the trees on the verge both at the front of the Horizon Power premises and some in front of our premises. When asked who said they could cut down the trees they said the Shire gave permission. Is this in fact true?

Answer – CEO Mrs Andrea Selvey advised that this would be investigated and a response to Mr Deimel will be provided in due course.

Mr Deimel also went on to discuss the drainage situation across the road near the old Beaurepaires building and that water backs up with heavy rain because the drains have not been maintained by Council for many years. These issues need to be fixed and this is not the only area in town with drainage issues.

Answer – The President addressed Mr Deimel and advised that the Council is acutely aware of the problems Carnarvon faces with many of these issues having been inherited by this Council from the previous Council. This Council is working hard to improve the amenity of Carnarvon and the issues we are facing and am proud of what this Council has achieved through adversity, particularly during the COVID years and the struggles that Council and the community faced. This Council works together and through all these

The Shire President, in closing wished to acknowledge the Council and staff for all their efforts and commitment over the past 2 years and am very confident that the Council is moving forward.

6.0 CLOSURE:

The Chairman declared the meeting closed at 12.24pm
